

**DYNABOOK AMERICAS, INC.  
DEBIT CARD REWARDS (SPIF) PROGRAM (M86650)**

**OVERVIEW**

Dynabook Americas, Inc. (“Dynabook”) announces a Debit Card Rewards (“Reward SPIF”) Program for select portable computers. Dynabook Partner Program (“DPP”) Resellers or their Sales Representatives (“Participants”) are eligible to receive the stated Reward SPIF for each ELIGIBLE PRODUCT purchased from an authorized Distributor and sold, invoiced, and shipped to U.S. end-user between January 3, 2021 and February 28, 2022 (the “Promotional Period”).

**ELIGIBILITY**

(1) Open only to DPP Participants who are U.S. citizens or legal U.S residents, 18 years of age or older and have purchased, sold, invoiced, and shipped ELIGIBLE PRODUCTS within the Promotional Period are eligible to participate in the Rewards SPIF Program. (2) Participants must have a valid DPP login account and must be registered using a company email account. Participates with Email domains, such as, Gmail, Hotmail, Yahoo, etc. will not be eligible to claim under such domains. (3) Participants must accept the Reward SPIF Program Terms and Conditions and Claim for the Reward SPIF by completing the Reward SPIF Claim Form within the DPP Rewards SPIF web site located at DynabookPartnerProgram.com, and (4) Participates will be required to provide their Social Security Number along with a W9 at time of claim. Employees of Dynabook America’s Inc. and/or its Authorized Distributors and their immediate family members are not eligible to participate. ELIGIBLE PRODUCTS are subject to availability and may be allocated in Dynabook and/or Distribution sole discretion. Dynabook Authorized Distributor and/or Strategic Partner Resellers sales representatives are ineligible for this program. Authorized Strategic Partners: CDW, Insight, SHI, and Zones and their noted affiliates.

**DEBIT CARD REWARDS**

Upon completion and validation of the Participates claim, Participant will receive through the U.S Postal Service a Dynabook branded Visa® Prepaid Reloadable Rewards Card along with the Visa® Prepaid Reloadable Rewards Card Cardholder Agreement. Once the card is activated, funds will be remitted to the card account representing the reward that was due. Then the card can be used to make purchases everywhere Visa debit cards are accepted. Balance and transaction details are available online or through a 1-800 number listed within the provided Cardholder information package.
